The meeting ends at 2.30 pm.











We, the members of the Internal Complaints Committee, have received the formal complaint lodged by Smt Susmitha Kumari S against Dr. Chithrakumar V K regarding the settlement of bills in connection with Graduation Ceremony of 2023 held on September 24, 2023. We received the complaint letter through Principal on September 29, 2023.

Adv. Elsa Praikalam, Sakhi's legal advisor who ought to be a member of the ICC committee, was contacted on September 29, 2023. She acknowledged that it was difficult for her to remain a member of our ICC because she was unavailable in Trivandrum. So, we wrote Sakhi a letter from our Principal's mail ID asking for another female member. We sent Sakhi a letter of reminder on Tuesday, October 3, 2023. The remaining members of the committee met in Room No. 307 starting at 3:30 PM on October 3, 2023.

We called the complainant and requested her to come to the meeting so we could inquire about complaint. Smt. Susmitha Kumari S recounted what happened at the Graduation Ceremony committee meeting held on September 27, 2023 at 1:00 PM in Room No. 319. Dr. Chithrakumar V K called her before the meeting to talk about settling the bill. His tone seemed out of character to her. She responded to him by saying that the meeting had been planned particularly by the Principal to assess the additional expenses that each committee claimed to have incurred. However, he became upset and claimed he was busy and had many other things to get done. After that, he entered the Room No. 319 to hand over the quotation documents and yelled at her, "soukaryamundenkil teacher ezhuthi vekk, enikk vere pani und. Ingane meeting koodikondirikkan enikk sanayamilla. Njan ente kayyeennu kodutholam ...chettethanam kanil...". According to her, he was reiterating the assertion while the door was open, and the students were also paying attention. In front of the students and the staff members who had gathered there for a meeting, she felt humiliated.

Then Dr Chithrakumar V K was asked to clarify the assertions he made against Dr. Susmitha Kumari S.

The committee found that the conflict between Smt Susmitha Kumari S and Dr. Chithrakumar V K was rooted in professional differences, miscommunication, and a lack of understanding. The committee is concerned that these conflicts following a successful event may demoralise the college teachers, who may then choose not to participate in future committees and events. The committee decided to recommend Principal to take steps to ensure that no staff members in the college utilize abrasive statements to one another because it is against the accepted workplace ethics.







[Translation in English of the Kerala Prohibition of Ragging Act, 1998 published under the authority of the Governor]

THE KERALA PROHIBITION OF RAGGING ACT, 1998\*

(Act 10 of 1998)

An Act to Prohibit ragging in educational institutions in the State of Kerala.

Preamble.- WHEREAS it is expedient to prohibit ragging in educational institutions in the State of Kerala.

BE it enacted in the Forty-Ninth Year of the Republic of India as follows:-

1. *Short title, extent and Commencement.*(1) This Act may be called the Kerala Prohibition of Ragging Act, 1998.

(2) It extends the whole of the State of Kerala.

(3) It shall be deemed to have come into force on the 23<sup>rd</sup> day of October, 1997.

2. *Definition.*-In this Act, unless the context otherwise required,-

(a) 'head of the educational institution' means the Principal or the Headmaster or the person responsible for the management of that educational institution;

(b) 'Ragging' means doing of any act, by disorderly conduct, to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or fear or shame or embarrassment to that student and includes-

(i)teasing, abusing or paying practical jokes on, or causing hurt to, such student; or

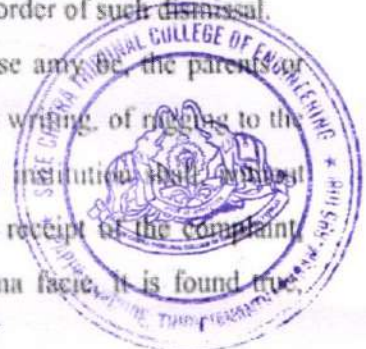
(ii) asking a student to do any act or perform something which such student will not, in the ordinary course willingly, do.

3. *Prohibition of ragging.*- Ragging within or without any educational institution is prohibited.

4. *Penalty for ragging.*- Whoever commits, participates in, abets or propagates ragging within, or without, any educational institution shall, on conviction, be punished with imprisonment for a term which may extent to two years and shall also be liable to a fine which may extent to ten thousand rupees.

5. *Dismissal of student.*- Any student convicted of an offence under section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of three years from the date of order of such dismissal.

6. *Suspension of student.*- (1) Whenever any student or, as the case may be, the parent or guardian, or a teacher of an educational institution complaints, in writing, of ragging to the head of the educational institution, the head of that educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint enquire into the matter mentioned in the complaint and if, prima facie, it is found true.





**Actions to be taken against students for indulging and abetting in Ragging in technical institutions Universities including Deemed to be University imparting technical education:-**

1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any technical institution in India.
2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
3. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
  - (i) Cancellation of admission
  - (ii) Suspension from attending classes
  - (iii) Withholding/withdrawing scholarship/fellowship and other benefits
  - (iv) Debarring from appearing in any test/examination or other evaluation process
  - (v) Withholding results
  - (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
  - (vii) Suspension/expulsion from the hostel
  - (viii) Rustication from the institution for period ranging from 1 to 4 semesters
  - (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
  - (x) Fine of Rupees 25,000/-
  - (xi) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggars.
4. The institutional authority shall intimate the incidents of ragging occurred in their premises along with actions taken to the Council immediately after occurrence of such incident and inform the status of the case from time to time.
5. Courts should make an effort to ensure that cases involving ragging are taken up on priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness.






